Fingerprint Requirement

All Holy Spirit Fremont employees and ministry members who are 18 years old and older must be fingerprinted.

First, select an approved fingerprint vendor closest to your local area from the list below. Call to schedule an appointment.

Second, bring the "Request for Live Scan" form to your appointment.

Third, The Diocese of Oakland has hired vendors at Live Scan Fingerprinting at the cost of **\$34.00 per volunteer**. If a volunteer goes to a fingerprint vendor **NOT** on our vendor list, the volunteer will be charged a **rolling fee** in addition to the **\$34.00 Diocesan fee**. Therefore, we encourage volunteers to use approved Diocesan vendors to avoid additional costs.

Please consider a monetary donation of \$34 to Holy Spirit Church to cover the cost of the fingerprint fee <u>and drop it off at the Rectory Office</u>. The fingerprint vendor will not request nor accept donations. The fingerprint vendor bills the Diocese who bills Holy Spirit.

Note, if you desire to work in <u>Audio Visual</u> you will have to request an "Employee Live Scan" form from peter@holyspiritfremont.org

If you have been fingerprinted for your job: The Department of Justice does not permit agencies to share fingerprint data. In other words, if you have been fingerprinted for your job; then you will need to be reprinted for the Diocese of Oakland. The Diocese is not permitted to contact your employer or any agency and request your fingerprint data.
